This Competition will count for:

- Czech Autocross Championship (RB125, RB250, D2, TA, TA1600, CrossCar, JB, B1600, SB)
- Czech Trophy (RB160, D7, D8, D9)
- MASCOM CUP (Kartcross)

### c) Entry Fees

All competitors who have registered by the first closing date pay a deposit and insurance of  
**Ax: 5.600 CZK (255 €), Ax – JB: 5.200 CZK (240 €), Ax – RB: 3.600 CZK (165 €),  
Mascom: 4.980 CZK, (230 €)**

Those competitors who registered after the first application deadline will pay a deposit including insurance in the amount of CZK 8.000 (€365) for each car, Racer buggy CZK 6.000 (€ 275) for each car. Entry fee with insurance has to be paid in closing date of entries latest.

The Confirmation of payment will be handled during administrative checking.

As the entry form from the Driver and the confirmation of the acceptance from the organiser is considered as a contract, the Driver, not coming to the Competition, has to apologise giving the reason as soon as possible.

- d) Entry fees may be refunded only:
- to candidates who are not accepted
  - in the case of the Competition not taking place,
  - if the Competitor withdraws his entry no later than the Monday before the Competition. If the withdrawal is announced to the organiser between that Monday and the opening of the administrative checking, 50% only of the entry fee will be refunded.
- e) For the RB160 division, the uniform fuel Efecta 95 is determined from the petrol station Benzina ORLEN, 5. května 1540, Humpolec.

## **IV. INSURANCE**

### **a) Insurance coverage of the organiser**

The Autoklub CR concluded with Allianz Insurance, a.s. through the company PLATINUM Consulting s.r.o., the frame insurance contract No. 550012623 on insurance of liability of the organiser for damage caused to the others in connection with a sport enterprise up to the sum of CZK 11.000.000.

### **Insurance of competitors and drivers**

### **b) Insurance of competitors and drivers**

The part of the frame insurance contract No. 550012623 is insurance of cars of the participants against damages caused to third persons up to the sum of CZK 11.000.000 per one insurance event with co-participation of CZK 5.000. Any damage below CZK 5.000 will be paid by the driver who caused the damage; damages above CZK 5.000 will be paid by the insurance company without any co-participation of the insured. However, the insurance does not cover liability for the damages caused by event participant that the competitors cause each other in the course of sport event.

c) Each driver is obliged to conclude his personal injury insurance and to present a proof on request the administrative checking. The insurance of foreign drivers must include coverage of costs for possible medical treatment in the CR.

## **V. NOISE CHECKING**

For all cars, a limit of 100 dB is imposed.

## **VI. PRIZES AND CUPS**

The podium ceremony on the circuit will be held immediately after the races. The winners of the 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> prizes will follow an instruction of the marshals. Failure to attend this ceremony will be penalized by the loss of any monetary award / benefit associated with the corresponding position at the end of the race.

## **VII. OTHER INFORMATION**

### **a) Parc Fermé**

Only cars of Divisions TA, TA 1600, CrossCar, JB, B 1600 and SB having taken part in the Finals (not in the Semi-Finals) must be brought by the Drivers to the Parc Fermé immediately after the finish, except for cars not having completed the race for reasons other than problems with the engine. The cars shall remain in Parc Fermé for at least 30 minutes after the publication of the provisional results and until released by decision of the stewards.

There is no Parc Fermé for cars of other divisions but cars which having taken part in the Finals have to stay in a paddock at least 30 minutes after the publication of the provisional results.

## **b) Protests - Appeals**

All protests will be lodged in accordance with the Code.

All protests must be made in writing and handed to the Clerk of the Course or his assistant, or in their absence any of the Stewards of the meeting, together with the sum of € 460. If the protest requires the dismantling and re-assembly of different parts of a car, the claimant must make a deposit of € 10000 maximum.

Competitors have the right to appeal, as laid down in Articles 15.2, 15.3 and 15.4 of the Code and also as set out in the Rules of the International Court of Appeal. The amount of the appeal fee is € 900.

## **c) The Drivers' Liaison**

The Drivers' Liaison Officer will be recognisable by orange vest. His picture will be posted on Official Notice Board. He may be reached at the driver's paddock.

- a) Driver and all members of his team have to wear appropriate tickets all the time, they will receive these tickets (1+4) at the administrative checking.
