3.2 In accordance with the regulations of the FIA Central European Zone Championship ,the starting permission for abroad is not obligatory

3.3. **Entry fees**

1st closing date of entries : 120,- €

2nd closing date of entries: 170,- €

All the fees will be collected during the administrative checking.

4.1 The event is written in the SAMŠ calendar and it is insured against the driver 's responsibility toward third parties.

4.2 Each driver is obliged to conclude his personal injuri insurance.

V. **NOISE CHECKING**

For all cars , a limit of 100 dB is imposed.

VI. **PRIZES AND CUPS**

6.1 Prices

The price giving ceremony will be organised after the Finals. Each driver of the 1st, 2nd and 3rd places must be present on the Prize giving Ceremony dressed in racing dress.

6.2. Financial prices

Financial prices will not be payed, drivers will be awarded prices.

6.3. Prices and cups

The Awards Ceremony will be organised after the Finals.

VII. **OTHER INFORMATION**

7.1. AMENDMENTS – INTERPRETATION

In accordance with Article 3.6 of the Code, no alterations shall be made to these Regulations after the opening date for entries, unless unanimous agreement is given by all Competitors already entered, or by decision of the stewards for reasons of Force Majeure or safety.

Any further information will be announced to the Competitors by dated and numbered bulletins which will be an integral part of these Regulations. These bulletins and all decisions will be posted on the official notice board on yellow paper.

. 7.2 Protest - appeals

All the protests will be lodged in accordance with the International Sporting Code.

All the protests must be made in writing and handed to the clerk of the course or his assistant, or in their absence to any of the stewards of the meeting, together with the financial sum.

7.3. Fire Extinguishers

Each driver is responsible for ensuring that a single piece extinguisher of minimum 5 kg is available within his own team area inside the paddock.

7.4. Protection of the Environment

Each driver is requested to ensure that a plastic sheet (minimum 4 metres by 5) is spread on the ground in the place reserved for his team where work is to be done on his car, in order to prevent any pollution in case of an accidental leak, et.

- 7.5. Driver Liaison Officer Vladimír Gubáň, will be reached in driver's paddock close to entrance to the track during all the championship. The Drivers' Liaison Officer will be recognisable by yellow vest and his picture will be posted on the Official Notice Board .
