Competitors from abroad must have their consent to their ASN in accordance with Article 2.3.7 of the ISC.

The maximum number of participants in a division is 30. The total number of participants in all divisions is a maximum of 160. The selection of accepted applications is determined by the organizer.

c) ENTRY FEES

All competitors who have registered by the first closing date pay a deposit of CZK 3,000, insurance of CZK 480 and CZK 1020 for other services, total of CZK 4,500 (€ 180) for each car.

Racer buggy - deposit 2,400 CZK, insurance 119 CZK and other services 981 CZK
ie a TOTAL of CZK 3,500 (€ 140) for each car.

Those competitors who registered after the first application deadline will pay a deposit including insurance in the amount of CZK 7,020 (€ 280) for each car, Racer buggy CZK 5,500 (€ 220) for each car.

Entry fee has to be paid in closing date of entries latest.

The Confirmation of payment will be handled during administrative checking.

The foreign drivers, will pay the entry fees only at the administrative checking.

As the entry form from the Driver and the confirmation of the acceptance from the organiser is considered as a contract, the Driver, not coming to the Competition, has to apologise giving the reason as soon as possible.

Entry fee has to be paid before closing date of entries:

- 2. 8. 2021, 1st closing date of entries
- 13. 8. 2021, 2nd closing date of entries

d) Entry fees may be refunded only:

- to candidates who are not accepted
- in the case of the Competition not taking place,
- if the Competitor withdraws his entry no later than the Monday before the Competition. If the withdrawal is announced to the organiser between that Monday and the opening of the administrative checking, 50% only of the entry fee will be refunded.

e) Weight of the cars

IV. INSURANCE

a) Insurance coverage of the organiser

The ACCR concluded with "Allianz Insurance, a.s.", through the company PLATINUM Consulting s.r.o., the frame insurance contract No. 400046134 on insurance of liability of the organiser for damage caused to the others in connection with a sport enterprise up to the sum of CZK 10.000.000.

b) Insurance of competitors and crews

The part of the frame insurance contract No. 400046134 is insurance of cars of the participants against damages caused to third persons up to the sum of CZK 10.000.000 per one insurance event with co-participation of CZK 5.000. Any damage below CZK 5.000 will be paid by the driver who caused the damage; damages above CZK 5.000 will be paid by the insurance company without any co-participation of the insured. However, the insurance does not cover liability for the damages caused by event participant that the competitors cause each other in the course of sport event.

c) Each driver is obliged to conclude his personal injury insurance and to present a proof on request the administrative checking. The insurance of foreign drivers must include coverage of costs for possible medical treatment in the CR.

V. NOISE CHECKING

For all cars, a limit of 100 dB is imposed.

VI. PRIZES AND CUPS

The podium ceremony on the circuit will be held immediately after the races. The winners of the 1st, 2nd and 3rd prizes will follow an instruction of the marshals. Failure to attend this ceremony will be penalized by the loss of any monetary award / benefit associated with the corresponding position at the end of the race.

VII. OTHER INFORMATION

a) Protests - Appeals

All protests will be lodged in accordance with the Code.

All protests must be made in writing and handed to the Clerk of the Course or his assistant, or in their absence any of the Stewards of the meeting, together with the sum of € 460. If the protest requires the dismantling and re-assembly of different parts of a car, the claimant must make a deposit of € 10000 maximum.

Competitors have the right to appeal, as laid down in Articles 15.2, 15.3 and 15.4 of the Code and also as set out in the Rules of the International Court of Appeal. The amount of the appeal fee is € 900.

b) The Drivers' Liaison Officer

The Drivers' Liaison Officer will be recognisable by orange vest. His picture will be posted on Official Notice Board. He may be reached at the driver's paddock.

Appendix 1

a) The driver, mechanics and escort will wear a visible sign throughout the race, which will receive 1 + 3 pieces at the administrative check or on arrival at the premises. Another 3 identification tapes for escorting crews can be purchased on the spot for the price of 250 CZK / 1 piece. If you are caught by the security service, the organizer caught without an identification tape, you must buy it, or it will be taken out of the race area.

Due to the limited capacity of the depot, no additional escort vehicles will be admitted to the complex. An exception may be granted by the organizer, but the competitor is obliged to place this vehicle in his own reserved space, which was allocated to him in the depot by the organizer. To identify the vehicle will receive the competitor must have a marking visibly affixed to the vehicle. Violation of the agreed provision parking of vehicles outside the driver's place in the depot can be fined by a contractual penalty in the amount of CZK 10,000.

b) During the whole weekend, a ban on the use of motorcycles, ATVs and other motor or electric vehicles is issued in the entire motoring area of the racecourse and other adjacent private lands under a fine of CZK 10,000 for riders and their companions. An exception may be granted by the organizer

c) Night rest is set at 24.00 - 6.00 hours.

d) Upon arrival at the car park for racing machines, the riders will be allocated a parking space according to the instructions of the car park manager.
