ELIGIBLE COMPETITORS:

Anybody carrying a valid national / international license (EU or Central European Zone) can become a contestant.

5. ENTRY FORMS:

- 5.1. Applications must be at Secretariat latest on 19th July 2012.
- 5.2. Contestants from abroad will have to include consent of their ASN in accordance with the Art.70 of the International Sporting Code.
- 5.3. MAXIMUM NUMBER OF CONTESTANTS IN EACH DIVISION IS 30.

6. ENTRY FEE:

- 6.1. Regular entry fee (start and insurance) is set to 2000 CZK (EUR 80) for each vehicle. Racer buggy fee is 1600 CZK (EUR 64). Increased late entry fee (RB included) is 3000 CZK (EUR 120)
- There will be also a fee 500 CZK (20 EUR) for energy and services for each contestant.
- 6.2. Increased fee could be required when a contestant declines to carry sponsor advertisement.
- 6.3. Fees shall be returned only in case of cancellation of this event.

INSURANCE

- 7.1. The Autoclub CR concluded with Ceska podnikatelska pojistovna a.s. Vienna Insurance group through intermediary RENOMIA a.s. insurance contract no. 0013950410 of liability of the organiser for damage caused to others in connection with a sport enterprise up to the sum of 5 000 000 CZK.
- 7.2. Included in above frame contract is insurance of cars of the participants against damages to third parties to the sum of 3 000 000 CZK. Damages to 5 000 CZK will be covered by the driver, who caused the damage, above 5 000 CZK (to the limit) shall be the sole responsibility of the insurance company. The insurance does not cover liability for damages caused by event participants to each other in the course of the event.
- 7.3. Every driver is obliged to conclude his/her own personal injury insurances and prove their validity at the admin. check. Starters from abroad must have and carry all insurances (incl. medical) valid specifically for Czech Republic.

IV. CHECKING

8. ADMINISTRATIVE CHECKING

8.1. Admin. checks shall be conducted at times posted, on the first floor of the control tower. All potential contestants or their official representatives must go through the administrative checking procedure.

8.2. All fees in proper amounts shall be paid and respective receipts presented with the documents needed for admin. checking.

9. SCRUTINEERING

- 9.1. Contestants or their official representatives must present each participating vehicle for the technical inspection procedure in the delegated area of the paddock.
- 9.2. Vehicles not conforming to safety rules of FIA (Appendix J) will be excluded from the race.

V. RUNNING OF THE EVENT

12. PRACTISES AND INFORMATION FOR STARTERS

12.1. There will be two timed qualifying practise sessions (second in reverse sequence) and these **are** mandatory for each division. Each SESSION is FOR 3 LAPS, timing shall be registered onward the second lap.

Maximum number of vehicles on track by divisions: SB, B1600, JB, D7, D8 - 7 cars

TA, D5, D6, H - 8 cars RB, Kartcross - 10 cars

14. QUALIFYING

By divisions: RB 160, RB 125, RB 250 - 4 rounds

VII. PRIZES AND CUPS

21.1. The prize giving ceremony will be conducted immediately after the last final run in front of the control tower. Drivers having achieved first three positions are obligated to join in the ceremony; otherwise their prizes shall be forfeited.

VIII. ADDITIONAL INFORMATION

22. FIRE EXTINGUISHERS

Each driver has to assure a fire extinguisher of minimum weight of 5 kilograms will be at hand at all times in his / her team area.

23. ENVIRONMENTAL PROTECTION

Each driver is requested to ensure that a plastic sheet (minimum size of 4 x 5 metres, RB 2x3 metres) is spread on the ground under his / her race vehicle in order to prevent any contamination and absorbing substance suited for petroleum products must be at hand. (Art. 2. 13.5. NSŘ) at all times.

24. COMPETITOR LIAISON OFFICER

Competitor liaison officer will be reachable in the vicinity of the control tower. Their pictures will be posted on the official information boards.

20. Appendix

20.1. All drivers, mechanics and all accompanying personnel must carry at all times the identification tag which will be issued (max 3 pcs. for a contestant) at the administration checking. More ID TAGS can be purchased at 100 CZK / a pc. Those without ID must buy ID tag or leave the paddock area immediately.

Due to limited parking only 1 accompanying vehicle will be admitted for each contestant. This vehicle must be parked within the limits of the respective assigned spaces. Identification of each vehicle must be always visible. Illegal parking can be fined by 10 000 CZK.

20.2. During the event there will be enforced a strict ban on riding motorcycles or driving four wheelers in the entire area and adjoined properties - under a collectable fine of 5000 CZK.

20.3. Night peace is to be observed from Midnight till 6:00 AM.
